1 Welcome to AllworxTM

The Allworx 10x is an integrated business productivity and communications solution comprising telephone features, networking capabilities and group collaboration tools. The Allworx User's Guide provides you with the information and instructions needed to:

- Set up and manage your personal contact list
- Benefit from the features of the All-in-One™ inbox, the Allworx unified messaging capability
- Share documents with others in your organization
- Use the various features of your telephone handset

2 Getting Started

Welcome to Allworx. This section provides information about:

- PC requirements for users and system administrators
- Installing the Allworx Communication Center software
- Making the first connection to the Allworx server
- Tasks and Reminders List

2.1 User PC Requirements

The Allworx features and functions are controlled through a PC client application called the Allworx Communication Center. The Allworx Communication Center provides a window through which you interact with the Allworx system. Your PC must have the Allworx Communication Center installed to access collaboration features such as calendar, email, scheduling and contact management. Check with your system administrator to be sure your PC meets the requirements listed in the following sections.

2.1.1 Operating System

Be sure your PC has one of the following Microsoft® operating environments:

- Windows XP Home and Professional
- Windows 2000

2.1.2 Hardware

Your PC should also meet the following minimum requirements:

- 64 MB of RAM
- 25 MB of available hard disk space
- A 10/100 BaseT network interface card (NIC) connected to the Allworx server over a local area network
- Speaker(s) and sound card
- Keyboard, mouse and monitor
- CD drive

2.1.3 Browser Software

The Allworx system supports the following browsers:

- Internet Explorer 5.5 or greater
- Netscape 6.2 or greater
- Opera 7.0.3 or greater
- Mozilla 1.3 or greater

2.2 Installing the Allworx Communication Center Software

Each Allworx system comes with an Allworx Communication Center software CD (part number 6000140). Contact your system administrator to obtain this CD. The Allworx Communication Center is designed to run only on Windows PCs.

Note: A copy of the Allworx Communication Center software is also stored on the Allworx website in the event the CD is lost or damaged. Contact your System Administrator if you need to access the Allworx website for the software.

To install the Allworx Communication Center software from the CD:

- 1. Remove the CD from its protective case and insert it in the PC's CD drive.
- 2. The Install Wizard will automatically start. Follow the instructions on the screen to complete the installation.

Note: If the Install Wizard does not automatically start, open My Computer on the PC desktop, and double-click on the CD drive icon. Locate the file named "Setup.exe" and double-click on it to start the Install Wizard.

When the Setup Type window appears, the Wizard offers the options for Typical or Custom installations. Select <u>Typical</u> to ensure only the Allworx Communication Center is installed.

When the installation is complete, the Allworx shortcut icon will appear on the desktop.



2.3 Logging On to the Allworx Communication Center

You will need your logon ID and password to access the Allworx Communication Center. This information is on the Welcome Message you may have received previously. Contact your System Administrator if you do not have your logon information.




Figure 2-1 – Logon Dialog Box

1. Double-click on the Allworx icon on the desktop. The logon dialog box will appear (Figure 2-1).

Notes: If the Logon dialog box does not appear and an error is message is displayed, check the network connection to the Allworx server or contact your System Administrator.

If the Allworx Communication Center was previously opened, click on the Allworx icon in your PC's Task bar at the bottom of the Windows screen to log in again.

- 2. Once you have logged on with the password assigned by your System Administrator, you may want to change it. Refer to Section 3 to change your password.
- 3. Immediately after logging on the <u>Tasks and Reminders</u> window may appear. Refer to Section 2.5

2.4 Allworx Communication Center Overview




Figure 2-2 – The Allworx Communication Center

The Allworx Communication Center helps you quickly locate and activate the various features and functions of the Allworx system. Figure 2-2 is an example of the Allworx Communication Center display.

Drop -down

View Pane

The View pane provides single-click access to the Contacts and Calendar functions of the Allworx system.

Information Pane

The Information pane provides the details of the function you selected in the View pane. For example, it will display your list of contacts.

Task Bar

The Task bar provides single-click access to commonly used functions.

The Exit button is used to close the Allworx Communication Center window and application.

The <u>Logoff</u> button is used to close the Allworx Communication Center and log off. The Allworx Communication Center will remain active. It can be opened again by double- or right-clicking on the Allworx icon in your PC's Windows Task bar. You will need to login again next time you open the Allworx Communication Center.




Figure 2-3 – The Allworx Communication Center Layout Manager

The <u>Layout Manager</u> button is used to create multiple information areas as shown in Figure 2-3. You can arrange your Information pane layout in four different ways - single window, double window horizontally split, double window vertically split, or triple window.

To create your preferred Information pane layout:

- 1. Click on the picture in the <u>Layout Manager</u> dialog box of the Information pane layout you want. The Layout Manager dialog box will close automatically.
- 2. Click on the icon in the View pane of the desired function to select the function to display in each window. Or make your selection from the drop-down feature list in the upper right corner of the Allworx Communication Center. Repeat this for each window.
- 3. Set each window to the size you prefer by moving the dividing line(s) up or down, or left or right depending on the layout. Place your mouse pointer on the line. When the pointer changes to a double arrow click and drag the line to the desired location. Release the mouse when the window is the right size.
- 4. To save the Information pane layout, click the <u>Layout Manager</u> button again. Highlight the contents of the <u>Store a Layout</u> field and type in a name for your new layout. Click <u>Save Current Layout</u> to save the new layout.

To restore a particular layout, click the <u>Layout Manager</u> button. Open the pull-down menu in the <u>Restore a Layout</u> section of the dialog box. Highlight the layout you wish to use and click. The dialog box will close and the new layout will appear in the Allworx Communication Center.

To delete a particular layout, click the <u>Layout Manager</u> button. Click the <u>Browse</u> button in the <u>Delete a Layout</u> section of the dialog box. Select the location and file name of the desired layout. Click <u>Delete Layout</u>. Close the <u>Layout Manager</u> dialog box.

The <u>User Settings</u> button is used to enter and modify your user information including password, business and home addresses, business and home telephone numbers and email, and telephone features. User Settings are discussed in Section 3.

The <u>Reminders</u> button provides a list of reminders of calendar events for which you have been scheduled. You can also add your reminders by clicking the <u>Add Reminder</u> button.

The <u>About</u> button displays information about the Allworx Communication Center software such as version number

The <u>Help</u> button provides a brief introduction to the features and functions of the Allworx Communication Center.

Status Bar

The Status bar provides current information about the following Allworx operations:

The Current User field indicates your user name and the date and time when you last logged on.

The <u>Connection Status</u> field indicates the name of the Allworx server to which your PC is connected.

The My Presence field indicates your current location (e.g., In Office, At Home, etc.), which determines how your incoming calls will be handled as explained in Section 4.

2.5 Tasks and Reminders

The Allworx system provides reminders for various scheduled and personal activities. Each time you login, the <u>Tasks and Reminders</u> window may appear if reminders have been triggered. You can also check your tasks and reminders by clicking the <u>Reminders</u> icon on the Allworx Communication Center Task bar. You will receive reminders for events scheduled by others through the Allworx Calendar (Section 9). You can also create your own reminders for personal activities.




Figure 2-4 – Tasks and Reminders Window




Figure 2-5 – New Reminder Dialog Box

To create a new reminder, click the <u>Add Reminder</u> button. The window in Figure 2-5 will appear. Enter the <u>Subject</u> of the reminder, and the <u>date</u> and <u>time</u> at which the reminder is to expire (i.e., when the reminder should be activated and appear in the Tasks and Reminders List). Click <u>OK</u> to save the reminder.

When a reminder is presented, you can:

Dismiss – The reminder will be permanently deleted.

Remind me again... - Set a later time at which the reminder will reappear.

Open Appointment... - Display the details of the event.

3 Creating and Updating Your Personal Information

The Allworx system allows you to manage your system identification information, personal information, and a variety of system features.

This section provides information about:

- Displaying and changing your system identification
- Displaying and changing system features
- Displaying and changing your personal information




Figure 3-1 – User Settings – System User Information Dialog Box

Click the <u>User Settings</u> button on the Allworx Communication Center task bar. The Update System User Settings for *Allworx User (Login ID)* dialog box will appear (Figure 3-1).

The **System User Info** tab allows you to update your identification information and certain Allworx system features.

Identification

You can change your Full Name, Display Name and Password.

The <u>Full Name</u> field includes first, last and middle names. Enter the name directly in the field. Or, click the down arrow to fill in the <u>Full Name</u> form, including prefix (Mr., Mrs., etc.) and suffix (Jr., II, etc.).

The <u>Login Name</u> field becomes part of the Allworx email name (e.g., jwb@yourcompany.com).

The <u>Display Name</u> field is used for Caller ID. It is automatically filled in as the Full Name field is entered, but can be changed.

The <u>Password</u> must comprise at least 4 alphanumeric characters, and cannot have special characters (?, /, etc.).

Click <u>Change Password</u> to change your password. The Password Reset dialog box will appear.

- 1. Enter the password in the New Password field.
- 2. Enter the new password again in the <u>Verify New Password</u> field. Type it exactly the same as in the New Password field.
- 3. Click the <u>Apply</u> button. If the password is not accepted, an error message will appear. Repeat the Password Reset at step 1. If the password is accepted, the Password Reset dialog box will close.

The <u>Phone Extension</u> is the extension number assigned to you by the System Administrator.

System Features

The <u>System Features</u> section of the dialog box has been setup by your System Administrator giving you permission for one or more of the following features. Contact your System Administrator if you have questions about your access to these features.

<u>Voicemail</u> – If <u>Enable</u> Voicemail is checked you have access to voicemail services. Note the maximum number of voicemail messages you have been allocated.

<u>Enable Dial-by-Directory</u> – If this box is checked, your name will be played in the Allworx auto-attendant directory (...John Smith extension 114...).

<u>Email</u> – If <u>Allow POP3 Email</u> Access is checked, you have the ability to receive external email in your Allworx Inbox. Note the amount of disk space allocated to you for both voicemail and email messages.




Figure 3-2 – User Settings – Person Information Dialog Box

The **Person Info** tab (Figure 3-2) allows you to enter more information about yourself or update existing information. Your System Administrator may have filled in some of this information previously.

The <u>Primary Address</u>, <u>Primary Phone</u>, and <u>Primary Email</u> fields represent information that will be visible throughout the Allworx system.

Click the <u>Private</u> box if the information in this form is to be confidential.

Click the <u>Update</u> button to save new or changed information.




Figure 3-3 – User Settings – Person Details Dialog Box

The **Person Details** tab (Figure 3-3) allows you to enter still more information about yourself. Your System Administrator may have filled in some of this information previously.

Click the down arrow next to the <u>Birthday</u> and <u>Anniversary</u> fields to display a calendar. Click the left and right arrows to change the month display. Click the date desired.

The <u>Notes</u> field can contain any other information about the user. You can also paste information into the field from other applications such as Microsoft Word.

Click the <u>Update</u> button to save the information.

4 Creating and Updating Your Telephone Handset Information

You can enter and update features of the physical telephones, referred to as handsets in the Allworx system. This section provides information about:

- Modifying handset features
- Creating and updating presence profiles and call routes

4.1 Handset Features




Figure 4-1 – User Settings – Handset Info Dialog Box

The **Handset Info** tab (Figure 4-1) allows you to change certain features and settings of any handsets assigned to you.

Handsets Assigned to User

This section of the window provides a list of handsets that have been assigned to you. Select a handset in the left pane to show its associated information in the right pane.



Phone: (description)

The description reflects the name of the handset assigned by the System Administrator and the associated analog port or TCP/IP address.

The <u>Outgoing CallerID</u> and <u>Phone Description</u> are automatically filled in by the Allworx or may have been completed by the System Administrator. However, you can change the entries in these fields. Place your mouse pointer in a field and click to change the entry.

The <u>Outgoing CallerID</u> field will appear on handsets within your organization that have display capabilities.

Note: The Outgoing CallerID is not passed to the telephone company and will not appear on telephones outside your organization.

The <u>Phone Description</u> field can be any meaningful description such as Line 2, Marketing Fax Machine, etc.

This Handset's Call Handling

The Handset Call Handling features may have been set by the System Administrator. However, you can now make changes. These features apply specifically to the handset for which they are defined as indicated by the <u>Phone Description</u>.

To activate <u>Do Not Disturb</u>, check the box. Incoming callers will hear a ring tone, but the handset will not actually ring. Calls to this handset will be routed as defined in <u>User</u> Extension Setup.

To activate call forwarding, click the <u>Forward to Ext</u>. button. Open the pull-down menu and click the desired extension.

Advanced Setup

<u>Advanced Setup</u> features may have been assigned to your handset. You cannot change these features. Contact your System Administrator for information about these features.

Item	Description	
Allow Making Calls	Indicates whether calls can be made from this handset to internal handsets or outside numbers.	
Outside Calls Do Not Require 8 + PINCode	May require users to enter an authorization code to place outside calls. The PIN code must always begin with 8, followed by 5 digits.	
When calling outside	Indicates the telephone company lines and the order in which they are used for calling outside.	
Enable Receiving Calls	Indicates whether incoming calls are permitted on this handset. If not enabled, callers will hear ring tones and the call will be handled according to the designated call route.	



Second Call Handling	Supports the following options for how a second incoming call should be handled:		
	Option	Description	
	Busy	The caller hears a busy signal and the On the Busy Call Route is followed.	
	Not Busy	(Only applies to analog handsets.) The caller hears a ring signal and the <u>Primary Route</u> is followed.	
	Call Waiting	The call recipient receives a beep tone every 16 seconds while the second incoming call is active. The <u>Primary Route</u> is followed.	
Enable Message Waiting Stutter Dial Tone			
Enable Message Waiting Light*	Provides a visual indicator to the user that a message is wait. If the handset does not support this feature, be sure this feature disabled.		
Enable Caller ID Display*	Click this box to present the incoming caller's ID on the handset's display. If the handset does not support this feature, I sure this feature is disabled.		
Handset Caller ID Type	Select the caller ID code format from the pull-down menu. Refer to the manufacturer's documentation provided with the handset.

4.2 Creating and Managing Presence Profiles

Allworx allows you to set up inbound call handling plans to accommodate a variety of scenarios. This high degree of flexibility will meet the needs of multi-location organizations, remote management situations, frequent travelers or telecommuters. Calls can be routed and terminated in a variety of ways depending on your active Presence profile. A different call route and termination arrangement can be configured for any or all of the following presence profiles.

The marketing manager may set her presence profile to "At a Meeting," so her calls are first be routed to the main receptionist. If the receptionist does not answer or his handset is busy, the call is then routed to the manager's voicemail. Or, when she changes her presence profile to "On a Business Trip," her calls might be directly routed to her cell phone.

A presence profile is made up of one or more <u>Caller ID Filters</u> and their associated <u>Call Routes</u>. The caller ID information of each incoming call is compared to the caller ID filters in the order defined. When the caller ID information matches a filter, the associated call route and termination plan is applied.




Figure 4-2 – Primary Call Route for Caller ID Filter 315*

For example, the regional sales manager, Carl Jones, sometimes does his paper work at home and wants calls from his western New York territory (area codes 315, 716 and 585) routed to the assistant sales manager, Todd Smith, who is in the office. All other calls should terminate directly to Carl's voicemail. Figure 4-2 shows the caller ID filters in the left pane of the window. Caller ID filter 91315* is highlighted, and the associated <u>Primary Route</u> is shown in the right pane of the window. (91 is an internal prefix attached to the caller ID filter).




Figure 4-3 – Primary Call Route for Caller ID Filter *

Figure 4-3 shows the caller ID filter for all other calls outside the western New York territory. All calls are routed directly to Carl's voicemail after the handset rings one time.



In addition to the Primary Route, you can also define an On Busy Route to a caller ID filter. If any of the handsets or extensions in the Primary Route ring busy, the call is directed according to this secondary route.

Lastly, you can set up a Presence profile even if you don't have a handset, but have an extension (for example, voicemail boxes only). Consider the telecommuter who has calls directed to a headquarters office. The call may first come to an administrative assistant, but route to the user's voicemail if that line is busy or not answered.

4.2.1 Creating Caller ID Filters

Creating Caller ID filters is the first step in building a Presence profile.

- 1. Click the <u>User Settings</u> button in the Task bar of the Allworx Communication Center. The dialog window will display several tabs in the Update User Settings dialog box.
- 2. Click the <u>User Ext. Setup</u> tab. The dialog box like the one in Figure 4-2 will be displayed.
- 3. Open the <u>Pick a Presence to Edit</u> pull-down menu and select a presence. The presence you select will contain the caller ID filters defined in the following steps. Call routing plans will be added in the following section.



4. Define the first Caller ID filter for the selected Presence profile. The default is all calls will receive the subsequent call route treatment. However, you can specify other Caller ID filters. To add a new filter:




Figure 4-4 -Add New Caller ID Rule Dialog Box

Click Add New Route. The window in Figure 4-4 is displayed.

Enter the Caller ID pattern for an <u>External</u> inbound call. For example, type 585* to choose all calls from the 585 area code. Or, click <u>Internal User</u> and choose an extension from the pull-down menu. For example, you may want to route all calls from your assistant to your cell phone for your <u>On Business Trip</u> Presence profile. Your assistant wouldn't need to remember your cellular number, just your internal extension.

- 5. Add as many Caller ID filters as you need for each Presence profile.
- 6. To remove a Caller ID filter, highlight the filter name, then click Delete Selected Route.
- 7. You can change the order of the Caller ID filters using the <u>Move Selected...</u> up and down arrows.
- 8. To create another Presence profile, open the pull-down menu and <u>Pick a Presence to Edit.</u> Repeat steps 1-7. You can create up to seven different Presence profiles.

4.2.2 Configuring Call Routes




Figure 4-5 – Ring Group and Hunt Sequence Call Route Example

The second step in creating a Presence profile is configuring the <u>Primary</u> or <u>On Busy</u> call routes for each Caller ID filter. Call routes can include simultaneous ring groups and hunt sequences, configurations common to many multi-line businesses (Figure 4-5). The steps below enable you set up call routes that meet the varying needs of your organization.




Figure 4-6 – Add Connection Attempt Dialog Box

To set up a <u>Primary Call</u> routing for a caller ID filter:

- 1. Be sure you have selected the correct <u>Presence to Edit.</u>
- 2. Highlight the Caller ID filter for which you want to configure the Primary call route.
- 3. Click No Connection Attempts Defined! Click to add. The Add Connection Attempt dialog box will appear (Figure 4-6).

4. Open the pull-down menu and highlight the first handset to which the incoming call will be directed. Click <u>Add</u>. Repeat this if more than one handset is to ring on the first attempt.

You can also specify the number of rings and the type of ring for each handset.

Click OK to save the first connection attempt telephone list.

5. If there is to be another connection attempt after the first has completed its sequence, click Click to add another connection attempt. Repeat Step 4 above.

Repeat Steps 4 and 5 until all connection attempts have been defined.

Click the X in the call attempt box to delete a call attempt.

6. Lastly, specify the action to take when the group has been exhausted. Click the appropriate button.

If <u>Voice Mail</u> is chosen, open the pull-down menu and select the user.

If <u>Call External Number</u> is chosen, select the format that is appropriate for the user and enter the external number.

Note: You can enter any domestic or international dialing plan, but no more than 31 digits. Enter asterisks between digits as needed to provide pauses to accommodate your telephone system. Each asterisk provides a 1-second delay.

7. Click <u>Update</u> to save the call route configuration.



Your active Presence profile (<u>My Presence</u>) will appear in the Allworx Communication Center status bar at the bottom of the window (Figure 2-2). Open the pull-down menu to change your call route as your presence changes.

If <u>Second Call Handling</u> has been defined as <u>Busy</u> (Advanced set up – check with your System Adminstrator) for any handset in the Primary call route, you can now define an <u>On Busy Route</u>. This route will be followed in the event any of those handsets in the Primary route rings busy.

- 1. Be sure you have selected the correct <u>Presence to Edit.</u>
- 2. Highlight the Caller ID filter for which you want to configure the On Busy call route.
- 3. Repeat steps 1-7 above.



5 Using the Features of Your Handset

The Allworx system supports standard analog handsets and more advanced internet protocol (IP) handsets. The Allworx handset features may operate differently depending on the type of handset and manufacturer. Check with your System Administrator if you are not sure about your handset.

This section provides information about making and receiving telephone calls, and about the call handling features of the Allworx system.

5.1 Making and Receiving Telephone Calls

5.1.1 Dialing External Phone Numbers

To dial an outside telephone number, lift your handset, listen for a dial tone, press <u>9</u>, and dial the external telephone number.

Note: You may hear silence for about two seconds as the phone number is sent to your local telephone company.

If you receive a busy signal after dialing, this can occur because either there is no available outside line or the called number is busy.

5.1.2 Call Blocking and Restrictive Dialing

Your System Administrator may have established rules for blocking outbound calls and restricting certain dialing patterns. Contact your System Administrator for more information.

5.1.3 Caller ID Display

The Allworx system will provide Caller ID information to your handset if this information is available from your local telephone company. Caller ID information may be stored on your handset and used for dialing back incoming callers. Contact your System Administrator for more information.

5.2 Allworx Call Handling Feature Operations for Analog Handsets

5.3 Allworx Call Handling Feature Operations for IP Handsets

The Allworx call handling feature descriptions for IP handsets are the same as for analog handsets. However, the features may operate differently for various IP handset models depending on the manufacturer of the handset. Consult the user's guide for your particular handset or contact your System Administrator for more information. Consult the Allworx website (www.allworx.com) for the current list of Allworx qualified handsets.

6 Managing Your Contacts

The Allworx Contact manager allows you to create and update your own list of important contacts, and see key organization contacts that are maintained by the System Administrator. This section provides information about:

- Displaying the organization's commonly used contact list and your personal contact list.
- Creating and maintaining your personal contacts, including
 - People contacts
 - Business contacts (companies and organizations)
 - Personal distribution lists or contact groups
- Key features and functions of the Allworx Contact manager

6.1 The Allworx Contact Manager

The Allworx contact manager provides a view of all contacts, the functions needed to display, update and delete contacts, and the ability to add new contacts. Click the Allworx Communication Center Contact button in the View pane (Figure 6-1).

Task Bar

The Task bar provides the ability to <u>add</u> new contacts and contact groups, <u>delete</u> contacts, <u>open</u> a contact to see more detail or update the information, <u>import</u> contact information from a file, export your contact list to an Excel document, and print contact information.

Menu Bar

The <u>Contact</u> pull-down menu provides the same functions as those displayed on the Task bar. The <u>View</u> pull-down menu allows you to select which columns of contact information to display in the Information pane.


Contact List Tabs

There are three *lists* of contacts that may be displayed using the **Contact Selection** Tabs under the Menu bar. The first list comprises your personal contacts and contact groups and is identified by your user name on the tab below the Task bar. The second list comprises Company contacts that your System Administrator creates and maintains. These are individual contacts and contact groups that are commonly used within your organization, for example suppliers, customers, or emergency contacts.

Note: Only the System Administrator can change Company contacts and groups.

The third list combines both personal and Company contacts. Click on the tab to select the list you need.





6.2 Adding a New Contact




Figure 6-2 – Add New Contacts Buttons

New contacts can be added by clicking on <u>New Person</u>, <u>New Business</u>, <u>New Resource</u>, or <u>New Group</u> on the Task bar (Figure 6-2).

<u>New Person</u> — Click on the <u>New Person</u> button to enter information about a new individual contact. Select the tab at the top of the dialog box to enter **Person Info** and **Person Details**. The <u>Primary Address</u>, <u>Primary Phone</u>, and <u>Primary Email</u> will appear in the Contact Screen list when the contact is saved. You can choose from any of the available options for these by selecting the desired entry from the pull-down menu associated with the field. Check the <u>Private</u> box if this contact is not to be viewed by others in your organization. After completing your entries and selections, click the <u>Add</u> button to save the new contact and close the window.

<u>New Business</u> - Click on the <u>New Business</u> button to enter information about a new business contact. Note that the business Contact Name will appear in the *Assistant's Name* column in the Allworx Contact Manager. After completing the Business Info fields, click the <u>Add</u> button to save the new contact and close the New Business Info window.

<u>New Resource</u> - Click on the <u>New Resource</u> button to enter information about a new resource. Resources are commonly used items or facilities that are shared within your organization. Contact name, telephone, and email may represent the person in your organization responsible



for managing the resource. After completing the Resource Info fields, click the <u>Add</u> button to save the new contact and close the Resource Info window.




Figure 6-3 – The Add Contact Group Members Dialog Box

<u>New Group -</u> Click on the <u>New Group</u> button to enter information about a new contact group The Add New Group Contact dialog box will appear (Figure 6-3). Contact groups are lists of people, businesses, resources or other groups that are related, for example, by function or location. Enter the name of the new contact group in the first field.




Figure 6-4 - Contact Picker Dialog Box

To add members from your Allworx contact list to your contact group, click the <u>Add Contact Members</u> button. The Contact Picker dialog box in Figure 6-4 will appear.

Highlight the entries in the left pane you wish to include in your contact group and click the $\underline{\text{Members}} \rightarrow \text{button}$. If you wish to remove members, highlight the entry in the right pane and click the $\underline{\leftarrow}$ button.

To find a name that does not appear in the left pane, begin keying the last name in the <u>Find Name</u> field. As you type, new contacts will appear that match the letters. Or, click and drag the scroll bar to display more contacts.

When you have completed adding contacts, click <u>OK</u> to save the contact group and close the window.

To add members that are *not* currently in your Allworx contact list, click the <u>Add Non-Contact Members</u> button. Enter the information in the dialog box (Figure 6-5) and click <u>OK</u> to save and add the contact to the group. The window will close automatically.

You can remove members by highlighting one or more entries and clicking the <u>Delete</u> button on the Add New Group Contact window.



When you have finished creating your contact group, press the <u>Add</u> button to save the contact group and close the Add New Group Contact window.

6.3 Updating Contact Information

To update a contact, highlight the entry in the Contact Manager window and click the <u>Open</u> button (or just <u>double-click</u> on the entry). When you have finished making changes, click <u>Update</u> to save the contact information and close the window.

6.4 Deleting Contact Information

To delete a contact, highlight the entry in the Contact Manager window and click the <u>Delete</u> button on the Task bar.

6.5 Contact Features

6.5.1 Searching Contacts

To search for a particular entry in the contact list:

- 1. Place your mouse pointer in any field of any contact entry in the list display.
- 2. Click once in the field.
- 3. Type the first few letters of the column-specific information for which you are searching. For example, if your are in the Name column, type the first few letters of the last contact's last name. Or, if you are in the email field, type the first few characters of the contact's email address. As you type, the Allworx Contact Manager will move to the entry that matches the characters you typed. The characters you typed will be highlighted in the resulting contact listing.

6.5.2 Selecting Contact Columns

You can choose which columns of information are to appear in your Contact Information pane using the View button on the Menu bar.

- 1. Click the <u>View</u> button, then move your pointer over the word Columns to display the Columns menu.
- 2. Highlight the column you wish to display or remove.
- 3. Click to check (select) or uncheck the column. The column will be added to or removed from the display. Repeat this process until all desired columns appear in the Information pane.
- 4. Click anywhere on the Information pane to close the View Columns menu and save your selections.

6.5.3 Column Control

You can change the position of the columns and change column width.

To change the *position* of a column:

- 1. Highlight the column heading.
- 2. Click and drag the column to its new location, moving either left or right.
- 3. Release the mouse when the column heading is in the desired location.

To change the *width* of a column:

- 1. Place the mouse pointer on the line separating it from the column to the right or left.
- 2. When the double arrow pointer appears, click and drag the line to the right or left.
- 3. Release the mouse when the column reaches the desired width.

6.5.4 Sorting Contacts

You can change the order of contacts displayed in the Contact Manager by clicking on the column heading. For example, names are normally shown in ascending (a-z) alphabetical order as indicated by the upward pointing triangle in the column heading. To reverse the alphabetical order (z-a), click on the column heading. The triangle now points downward.

6.5.5 Printing Contacts

To print contact listings:

- 1. Choose the contact list to be printed by clicking on the desired **Contact Selection** tab.
- 2. Click the <u>Print</u> button on the Task bar. Contacts will be printed in the order in which they are displayed.

Note: You may click the <u>Print Preview</u> button first to see how the actual printed output will appear.



7 All-in-OneTM Inbox PC Message Center

The Allworx All-in-One inbox provides convenient access to email, voicemail and calendar messages from your PC or from your handset. This section provides instructions for accessing and managing messages from your PC. Section 8 provides instructions for accessing and managing messages from a telephone. Important benefits of a unified message center include:

- Eliminating time and energy spent retrieving messages from multiple points.
- Increasing your productivity.
- Reducing communications errors, confusion with contacts and other problems that arise when there are too many messages from too many sources.
- Reducing message redundancy.
- Increasing the potential for better customer response time.

7.1 The Allworx Message Center




Figure 7-1 – Allworx Messages Center

The Allworx Message Center provides a view of all messages and the functions needed to manage messages. Click the <u>Messages</u> button in the Allworx Communication Center View pane (Figure 7-1).

The Allworx icon in your PC's Task bar will change to an "envelope" when a new message is received in your Allworx Inbox. New incoming messages are shown in bold type. Your inbox can include email, voicemail and calendar events messages as indicated by the icon to the left of each message.

To read a message, highlight the message and choose <u>File</u> and <u>Open</u>. Or, double-click on a message to open it. Once a message has been read the bold highlight is removed and the Allworx icon returns to normal.

To <u>Reply</u> to or <u>Forward</u> a message, highlight the message and click the appropriate command button.

If the <u>Preview</u> feature is turned on, you can do the following directly from the Allworx Messages Center:

- See the contents of the incoming message automatically.
- View message attachments
- Listen to your voice message directly from the Allworx Messages Center using the <u>Play</u> and Stop buttons and the playback progress control bar.
- Accept or decline calendar invitations.

Refer to Sections 7.3 - 7.5 for more information on reading and responding to different types of messages.



Task Bar

The Task bar mail features include:

Create New messages or message folders.

Delete unwanted messages.

Reply only to the sender.

Reply to All message recipients.

Forward the message.

Add a custom <u>Signature</u> to your messages. You can choose the font for your text and indicate whether the signature should be added automatically to new outgoing email messages.

Click the appropriate icon to Save and Print messages.

Click the <u>Home</u> icon to be automatically connected to the Allworx.com home page.

Menu Bar

The <u>File</u> button is used to open, save and print messages and includes Page Setup and Print Preview functions.

The Edit button is used to select all messages.

The <u>View</u> button allows you to select and change mail message headers, select tool bar options, and collapse or expand the folder list display. You can also choose to display a <u>Preview</u> of messages. The <u>Preview</u> mode allows you to see the contents of a message including attachments, view <u>Appointment Details</u> then <u>Accept</u> or <u>Decline</u> invitations, and <u>Play</u> voicemail messages.

The <u>Mail</u> button provides the same functions as those displayed on the Task bar. It also provides the following features:

- <u>Mark Message as Read/Unread</u> Applies bold face type to the message display as if it were a new message.
- <u>Set Message Priority</u> Allows you to indicate message priority as high (! appears), normal, or low (↓ appears). Sort your messages in priority order by clicking the Priority icon at the top of the column.

Changing Column Width

To change the width of a Message Header column, place your mouse pointer on the line between two columns. When the double-arrow appears, click and drag the line to change the column width.

Message Folders

The Allworx Message system provides several standard message folders:

The <u>Drafts</u> folder stores messages that were started but not yet sent. These messages can be reopened, edited, and sent as needed.

The Inbox folder contains all incoming messages.

The <u>Outbox</u> folder contains messages that are in the process of being sent. Messages usually stay in this folder a very short time unless there is a network connection fault. It may also contain messages that you created while working offline. These messages will be sent next time you connect to the Allworx server.

The <u>Sent</u> folder contains messages that have been sent. You should review this folder periodically and delete unwanted messages to preserve Allworx server disk space.

The <u>Trash</u> folder contains messages that have been deleted. You should review this folder periodically and delete unwanted messages to preserve Allworx server disk space. Messages deleted from the Trash folder are permanently removed.

To move messages from one folder to another:

- 1. Highlight the message in the message display window.
- 2. Click and drag the message to the desired folder in the message folder list.

You can create additional folders within any of the standard Allworx message folders:

- 1. Highlight the folder into which the new folder will be placed.
- 2. Click the drop-down arrow next to <u>New</u> in the Task bar and select <u>Mail Folder</u>. Or, you can just right-click on the folder in which you want to place the new folder and select New Folder.
- 3. Type the name of the new folder.
- 4. Press Enter on your keyboard.

Click the + or - box to expand or contract the message folder display.

7.2 Creating and Sending New Email Messages




Figure 7-2 – Allworx Email Message Window

To create a new message, click <u>New</u> in Task bar. The Allworx Message box will appear (Figure 7-2).

- 1. Enter the names of the message recipients in the To, Cc and Bcc fields. Or, click the button to open the Contact Picker dialog box. Select the contacts in the left window then click the right-arrow button to place the contact in the appropriate recipient box.
 - To remove a contact, highlight the name and click the left-arrow button.
 - Use the Manually Entered tab to enter recipients who are not in any contact list.
 - Click OK when you have completed your message's recipient lists.
- 2. Type the Subject of your message.
- 3. Type your message content using the various formatting and text editing features. The Allworx system provides very powerful text editing capabilities, similar to those found in Microsoft Word. These are shown in the Allworx Message Box Edit bar(s).
- 4. Click <u>Attachments</u> in the Task bar to include other documents with your message as needed.
- 5. Click <u>Send</u> in the Task bar when your message is ready.

Menu Bar

The <u>File</u> button is used to save and print messages and includes Page Setup and Print Preview functions. You can also open attachments.

The <u>Edit</u> button includes many text editing commands, including cut, copy and paste, find and replace, and undo and redo.

The <u>View</u> button allows you to select and change tool bar options, zoom in and out, and select various page layout options to simplify editing.

The Insert button allows you to embed files, pictures, symbols and links in your message.

The <u>Format</u> button is used to change the format of text, paragraphs, bullets and numbering.

The <u>Tools</u> button provides features to check spelling and a thesaurus.

The <u>Table</u> button is used to insert a table into the text of your message.

The Mail button provides the Send and Attachment functions as displayed on the Task bar.

The message is automatically saved in the <u>Sent</u> folder when you click the <u>Send</u> button.



7.3 Reading and Responding to Email Messages

To read a message, highlight the message and choose <u>File</u> and <u>Open</u>. Or, double-click on a message to open it. The Message display window indicates all message recipients, the message sender, date and time the message was received in your Allworx Inbox, subject, and message content. You can also read and manage your message in <u>Preview</u> mode.

Task Bar

The Task bar message functions allow you to:

Create a New message.

<u>Delete</u> the message.

Reply only to the sender.

Reply to All message recipients.

Forward the message.

Click the appropriate icon to <u>Save</u> and <u>Print</u> messages.

Click the <u>Home</u> icon to be automatically connected to the Allworx.com home page.

Menu Bar

The <u>File</u> button is used to open, save and print messages and includes Page Setup and Print Preview functions.

The Edit button is used to select and copy message content.

The <u>View</u> button allows you to select tool bar options.

The Mail button provides the same functions as those displayed on the Task bar.

7.4 Reading and Responding to Voicemail Messages




Figure 7-3 – Allworx Voice Message Window

To play a voicemail message, highlight the message and choose <u>File</u> and <u>Open</u>. Or, double-click on a message to open it. The Voicemail Playback window (Figure 7-3) shows the message sender, date and time the message was received in your Allworx Inbox, and the length of the recorded message. You can also read and manage your message in <u>Preview</u> mode

Task Bar

The Task bar provides <u>Play</u> and resume, <u>Stop</u> and <u>Pause</u> functions. Other mail functions include:

Reply only to the sender.

Reply to All message recipients.

Forward the message.

Delete the message.

Click the <u>Home</u> icon to be automatically connected to the Allworx.com home page.

Menu Bar

The File button is used to save the message or exit the playback window.

The <u>View</u> button allows you to select tool bar options.

The <u>Voice</u> button provides the same functions as those displayed on the Task bar.

Click and drag the playback progress control bar to select a particular point at which to play the message.

7.5 Reading and Responding to Calendar Messages




Figure 7-4 – Allworx Calendar Message Window

To read a calendar message, highlight the message and choose <u>File</u> and <u>Open</u>. Or, double-click on a message to open it. The Message display window (Figure 7-4) shows the <u>Subject</u> of the appointment, the appointment <u>Organizer</u>, all invited <u>Attendees</u>, and the date and time the message was received in your Allworx Inbox. You can also read and manage your message in Preview mode

Appointment Details include Start and End dates and times, event Location, and event Priority.

The organizer may have also included a Note to Attendees.

Task Bar

The Task bar message functions include:

Accept an appointment invitation.

Decline an appointment invitation.

<u>Add Response</u> when you Accept or Decline an appointment invitation. New Task and Menu bars are displayed. Click <u>Remove Response</u> to cancel.

Delete the message.

Click the Print icon to print the message.

Click the <u>Home</u> icon to be connected automatically to the Allworx.com home page.



Menu Bar

The <u>File</u> button is used to open, save and print messages, and includes Page Setup and Print Preview functions.

The Edit button is used to select, copy, and modify message content.

The <u>View</u> button allows you to change the <u>layout</u> of the message display, <u>zoom</u> in and out, and display vertical and horizontal <u>rulers</u>.

The <u>Insert</u> button allows you to add files, pictures, symbols, and links to your response message.

The <u>Format</u> button provides options for changing the appearance of text in your response message.

The <u>Tools</u> button includes options for spelling and grammar correction.

The <u>Table</u> button is used to insert a table into your response message.

The <u>Calendar</u> button provides the same functions as those displayed on the Task bar.

7.6 Using the Allworx Message Center Offline

You can create and send new messages while offline from the Allworx server. (Refer to Section 12 for information about working offline.) The messages will be stored in the Outbox folder until you reconnect to the Allworx server. Once you have reconnected and synchronized your PC, pending messages will be transmitted to the recipients.

While working offline, you <u>cannot</u>:

- Move messages from one message folder to another
- Create new message folders
- Delete messages

8 All-in-OneTM Inbox Telephone Message Center

The Allworx All-in-One Inbox Telephone Message Center provides a convenient way to play and manage your voicemail and email messages over the telephone. This section provides information about:

- Creating and updating your outgoing voicemail message.
- Playing, replying to and managing your messages.

8.1 Logging in to the Allworx Message Center

1. From any activated handset within the organization, dial 6 followed by your extension number. If calling from outside the organization, be sure you call in through the Auto Attendant. You will hear the standard welcome greeting. Press 6 followed by your extension number.

You will hear: "Welcome to the Allworx Message Center. Please enter your password followed by the pound sign. Or press pound now to change users. Press star to listen to these choices again."

2. Enter (or spell) your password using the handset keypad (see the table below), then press the #key. If you don't know your password, contact your System Administrator.

- 2. You will hear an announcement indicating the number of new and saved messages in your voicemail inbox and the following options:

4. Press <u>2</u>. Listen to the announcement and instructions, then record your name. Press the <u>#</u> <u>key</u> when you have finished. The system will replay your new name recording and offer the following options:

#	To cancel changing your name recording
*	To listen to these choices again

5. Press $\underline{1}$ to save your new name recording, then hang up.

8.3 Changing Your Name Recording

- 2. You will hear an announcement indicating the number of new and saved messages in your voicemail inbox and the following options:

5. Press <u>2</u>. Listen to the instructions and record your name. Press the <u># key</u> when you have finished. The system will play your new name recording, then offer the following options:

*	To listen to these choices again

6. Press <u>1</u> to save your name recording.

- 2. You will hear an announcement indicating the number of new and saved messages in your voicemail inbox and the following options:

3. Press $\underline{4}$. The system will announce the following options:

4. Press <u>3</u>. Listen to the announcement and instructions, then record your outgoing message recording. Press the <u># key</u> when you have finished. The system will replay your new message recording, and offer the following options:

3	To review your outgoing message
#	To cancel changing outgoing message
*	To listen to these choices again

5. Press 1 to save your new message recording.

- 1. Log in to the Allworx Message Center (Section 8.1)
- 2. You will hear an announcement indicating the number of new and saved messages in your voicemail inbox and the following options:

*	To listen to these choices again

3. Press $\underline{4}$. The system will announce the following options:

Command	Function
1	To change your password
2	To change the recording of your name
3	To change your outgoing message recording

*	To listen to these choices again



4. Press <u>3</u>. The system will play your current message for review and offer the following options:

Command	Function
2	To change your outgoing message
3	To review your outgoing message
#	To return to the previous menu
*	To listen to these choices again

5. Press <u>2</u>. Listen to the instructions and record your new message. Press the <u># key</u> when you have finished. The system will offer the following options:

Command	Function
1	To save your outgoing message
2	To change your outgoing message
3	To review your outgoing message
#	To cancel changing your outgoing message
*	To listen to these choices again

Press 1 to save your new message recording.

8.6 Voicemail Message Playback

The Allworx system may turn on the message indicator on your handset when you have a new message. Check your handset's user's guide for more information or contact your System Administrator to determine if your handset supports these features.

- 1. Log in to Allworx Message Center (Section 8.1).
- 2. You will hear an announcement indicating the number of new and saved voicemail and email messages in your inbox. The system will then prompt with the following options:



Command	Function
1	To listen to voicemail messages
2	To skip to playing saved voicemail messages
3	To send a message
4	To change your Message Center system settings
5	To <i>listen</i> to email messages
6	To skip to playing saved email messages
9 or hang up	To end your call
*	To listen to these choices again

3. Press 1, 2, 5, or 6. The system will announce the time the message was received and play the message. For email you will hear the sender's name, message subject and content.

After hearing the message select from the following options:

Command	Function
1	To reply to this message
2	To forward this message (voicemail messages only)
3	To delete the message
4	To replay this message
5	To play the previous message
6	To play the next message
7	To <i>rewind</i> the message 10 seconds (while listening to the message)
8	To advance the message <i>forward</i> 10 seconds (while listening to the message)
9	To place a call to the sender of this message. (Only applies to messages sent by other Allworx users)
#	To return to the previous menu
*	To listen to these choices again

Notes: Messages are automatically saved unless you choose to delete them.

To interrupt message playback and take an immediate action, press $\underline{*}$ followed by the command number. For example, to reply to a message before hearing the end of the message, press *1.

8.7 Replying to a Message

You can reply to new or saved messages received from people inside or outside your organization as follows:

- A message reply to an internal user will be left as a voicemail message and sent as an email message with an audio attachment (.wav file).
- A reply to email from an external system will only include the .wav file attachment.
- You cannot reply to voicemail messages received from outside your organization (for example, a call from an outside line answered by your voicemail).

To reply to messages:

- 1. After playing the message, press $\underline{1}$ to reply.
- 2. Listen to the announcement and instructions then record your message. Press the # key when you have finished.
- 3. Select one of the following options for sending your reply:

Command	Function
1 or Hang up	To send to your message
2	To review your message
3	To change your message
#	To cancel sending your message
*	To listen to these choices again

8.8 Forwarding a Voicemail Message

You can forward new or saved voicemail messages received from people within or outside your organization. You cannot forward email messages. Voicemail messages may be forwarded to one or more people within or outside your organization.

Note: Messages to external contacts are forwarded as audio attachments (.wav files) to email messages. Therefore, the intended recipients' email addresses must be predefined in the Allworx system. Contact your System Administrator for more details.

- 1. After playing the message, press 2 to forward.
- 2. After the Allworx prompt, enter the first extension number to which you wish to forward the message. The system will play the selected user's name, and prompt for the next extension number. You can enter another extension number, press 9 to send your message to all voicemail users, or press the #_key to finish entering forwarding extension numbers. Repeat this process until all extension numbers are entered.



- 3. When you have finished entering extension numbers, you will be prompted to record a message to precede the forwarded message. Record your message at the beep, then press the #key when you have finished.
- 4. Select one of the following options for sending your reply message:

Command	Function
1 or Hang up	To send to your message
2	To review your message
3	To change your message
#	To cancel sending your message
*	To listen to these choices again

8.9 Sending a Message

Messages can be recorded and sent to multiple users and Message Aliases.

Note: Message Aliases are predefined designations for voicemail distribution lists set up by the System Administrator, and are in range of 600-699. Refer to Section 8.10 for more information about Message Aliases.

To record and send a new message:

- 1. Log in to the Allworx Message Center (Section 8.1).
- 2. You will hear an announcement indicating the number of new and saved messages in your voicemail inbox and the following options:

Command	Function
3	To send a message
4	To change your Message Center system settings
9 or hang up	To end your call
*	To listen to these choices again

- 3. Press <u>3.</u> The system will prompt you to enter the first extension number or Alias number to which you wish to send the message. You can also press <u>9</u> to send your message to all voicemail users.
- 4. Enter the first extension number. The system will confirm your entry, and prompt you to enter another.



- 5. Enter the next extension or Alias number. Repeat this process until all extension or Alias numbers have been entered. When the last number has been entered, press the # key to indicate you are ready to record your message.
- 6. You will be prompted to begin recording. When you have finished recording, press #.
- 7. You will be prompted to complete the process as follows:

Command	Function
1 or hang up	To send a message
2	To review your message
3	To change your message
#	To <i>cancel</i> sending your message
*	To listen to these choices again.

8. Press 1 or hang up to send your message.

8.10 Viewing Message Distribution Lists

Distribution lists allow you to leave the same voicemail or email message for a related group of contacts by entering just one number. A distribution list is identified by an <u>Email Alias</u> or <u>Voicemail Alias</u> number in the range 600-699. Message Aliases will be created by your System Administrator. You can view the list of available Message Aliases using your PC's browser.

- 1. Locate the browser application on your PC (Internet Explorer or Netscape).
- 2. Double-click on the browser icon to open a window.
- 3. In the <u>Address</u> field, type the following then press <u>Enter</u> or click <u>Go</u>:

http://corp.yourcompanydomainname/

Note: Contact your System Administrator regarding your company's domain name.




Figure 8-1 – Allworx User Homepage

The Allworx User Home Page in Figure 8-1 will appear showing company directory and user listing information.




Figure 8-2 – Message Distribution Lists

4. Click <u>Distribution Lists</u>. The window in Figure 8-2 will appear listing all available Distribution lists and their associated Message Aliases.

The Allworx system automatically distributes the message to the individuals in the group. Internal users receive voicemail messages; external members receive .wav files attached to an email message.



When sending, replying to, or forwarding a message, you can enter the voicemail alias number for distribution to all members of the list. To send email to the distribution list, click on the <u>Email Alias</u>. Your PC's default email application (e.g., Outlook Express) will open. Enter and send your message accordingly.

9 Managing Your Calendar

The Allworx Calendar allows you to setup, manage and track meetings and events on a daily or monthly basis. This section provides information about:

- Scheduling and updating events and activities
- Sharing calendars

9.1 Calendar Overview




Figure 9-1 – Allworx Calendar Month Window

To access the Allworx Calendar, click the Allworx Communication Center <u>Calendar</u> button in the View pane. Figure 9-1 illustrates the <u>Month View</u> of the Allworx Communication Center calendar. Use the buttons on either side of the month name to move forward or back in time.

Task Bar

The Task bar provides the ability to create <u>New</u> events, <u>Open</u> and edit scheduled events, <u>Delete</u> events, and <u>print</u> the Calendar. The <u>Help</u> feature provides an overview of the Calendar features.

Menu Bar

The Menu bar provides the following capabilities:

The <u>File</u> button is used to print the calendar and includes Page Setup and Print Preview functions.

The <u>View</u> button allows you to display week numbers in the calendar.

The <u>Calendar</u> button provides the same functions as those displayed on the Task bar.

The <u>Help</u> button provides an overview of the Calendar features.




Figure 9-2 – Allworx Calendar Day View Window

The Calendar also provides a day-at-a-time view (Figure 9-2). Click the **Day View** tab to see the hours of the day. Use the scroll bar at the right of the Day View window to move forward or backward through the hours of the day. Click the <u>Yesterday</u> or <u>Tomorrow</u> to change the date accordingly. The day and date at the top of the window will change to reflect the selected day.

9.2 Scheduling a New Event

To create and schedule a new event:

- 1. Click New Event on the Task bar. The Appointment Item View window will appear, showing the Appointment Data dialog box.
- 2. Place your insertion point in the <u>Subject field</u>, and type the relevant subject of the event (for example, Sales Meeting, Customer Training, etc.).
- 3. Press <u>Tab</u> or place your insertion point in the <u>Location</u> field. Type the description of the location of the event, (for example, Main Conference Room, ABC Company address, etc.).
- 4. Open the pull-down menus and select the Meeting Type (Meeting, Multiday event or Occasion/Holiday) and Priority (High, Medium, or Low).
- 5. If the event is be recurring on a regular basis, click the <u>Recurrence</u> button. The Setup Meeting Recurrence dialog box will appear.
 - a. Click the button that reflects the recurrence pattern (for example, Daily, Weekly, Monthly, etc.) of your event.
 - b. Next, define the recurrence frequency. For example, if you clicked Daily, then you might indicate the event recurs every 3 days.
 - c. Indicate the recurrence range, including the <u>Starting</u> and <u>Ending</u> dates for the event using the pull-down calendar for these fields.
 - d. Finally, indicate the number of times the event should repeat during the date range indicated above.
- 6. Click the <u>Reminder</u> box to set an automatic reminder of the event. Then set the time at which a reminder is to occur in the recipients' reminder files in the Allworx Communications Center. For example, if the event is set for 9:00 and the reminder time is 10 minutes, the reminder will occur at 8:50.
- 7. Next, enter the <u>Date</u>, <u>Start</u> and <u>End Times</u>, and <u>Travel To</u> and <u>Travel From Times</u> using the pull-down calendar for these fields.
- 8. Enter any notes regarding the event, such as "Presentation of final sales numbers and forecasts." You can also paste text from other applications such as Microsoft Word. If the Notes are to be confidential, click the Private button to restrict access.
- 9. You can also <u>Add Attachments</u> using your PC's browser to locate and select the desired document(s).




Figure 9-3 – Appointment Item Window – Attendees Dialog Box

- 10. Click the <u>Attendees</u> tab to include others in your event. The Attendees dialog box (Figure 9-3) allows you to add and remove contacts, and plan a meeting venue (date and time) that accommodates the schedules of your invited attendees. To limit the view to only work hours, click the <u>Show Only Work Hours</u> box. The time frame for the event defined above is shown in red.




Figure 9-4 – Contact Picker Dialog Box

- 11. Click the <u>Add Attendees</u> button to display the Contact Picker dialog box (Figure 9-4). You can choose from a merged list of all contacts, or separate lists of Personal or Company contacts using the pull-down menu. Or, you can begin typing the last name to find the desired contact. Contacts matching your keystrokes are highlighted as you type.
- 12. Once the desired contact name is highlighted, click <u>Mandatory</u>, <u>Optional</u>, <u>or At Least One</u>. The contact name will be added to the appropriate attendee list.
 - To remove a contact from the attendee list, highlight the name and click the <u>left arrow</u> button. The name will be removed from the attendee list. Click <u>OK</u> when you have finished selecting your attendees. The Attendees dialog box will show the attendees' calendar information. Possible conflicts will be reflected as shown in Figure 9-3.
- 13. Click the <u>Manually Entered</u> tab in the Contact Picker to include attendees outside the organization. You must enter a valid email address. Once the desired contact name is entered, click <u>Mandatory</u>, Optional, or At Least One.
- 14. Click the <u>Add</u> button, when you are finished entering Appointment Data and Attendee information for the event. The Allworx Communication Center will appear showing the event on the scheduled day.

9.3 Updating an Existing Event

To update an event, <u>double-click</u> on the event in either the Month or Day view. The Appointment Item View window will appear. Make the changes to either the Appointment Data or Attendees. Click <u>Update</u> to save the changes. An update message will be sent to the attendees of the original event.

You can also change the Recurring information or Priority of the event directly from the Day View.

To change the Recurring information, place your mouse over the <u>Recurring Event</u> icon (Figure 9-2). Click when the finger pointer appears. The Setup Meeting Recurrence dialog box will appear. Make your changes and click <u>Apply</u> when you are finished.

To change the event priority, place your mouse over the <u>Event Priority</u> icon (Figure 9-2). Click when the finger pointer appears. A pull-down menu will appear from which you can select a new priority – high, medium, or low. The menu will close automatically after you make your selection.

9.4 Deleting an Event

To delete an event, highlight the event in either the Month or Day view. Click <u>Delete Event</u> on the Task bar. A confirmation message will appear. Click \underline{OK} to delete the event, or <u>Cancel</u> to keep it active.

9.5 Sharing Calendar Information

You can share your calendar with others in the organization, and they with you.

9.5.1 Viewing Other Users' Calendars




Figure 9-5 – Selecting Shared Calendars

To see the calendars of others in your organization, click the down arrow on the Calendar icon in the View pane. Click on the user's name to open his or her calendar. Or, open the function pull-down menu on the right side of the Allworx Communication Center (Figure 9-5) and click on the user's name. Any events that have been marked <u>Private</u> will not be displayed. You will also be restricted from seeing calendars of those who have not given you "read" permission (see Section 9.5.2 below).

9.5.2 Setting Up Viewing Permissions for Your Calendar

You can allow or restrict others in your organization from viewing (reading) your calendar. You can assign a default permission to all users, or assign permission to individual users. To define calendar viewing permissions:

- 1. Click the <u>User Settings</u> icon on the Allworx Communication Center Task bar.




Figure 9-6 – Resource Sharing – Permissions Dialog Box

- 2. Click the <u>Resource Sharing</u> tab. The window in Figure 9-6 will appear.
- 3. Set the <u>Default Allworx User Permissions</u>. Check the box to make <u>read</u> the default permission, giving all users unrestricted access to your calendar information. Uncheck the box to make restricted access the default for all users.
 - To set the default permission for all users, click the <u>Default Permissions for All Users</u> button. The <u>read</u> boxes for all users will reflect the default permission.
- 4. To override the default permission for an individual, check or uncheck the associated read box. You can reset the default permission by clicking the <u>Default Permissions</u> button.
- 5. Click the <u>Update</u> button when you have finished to save the permission settings.

10 Sharing Documents

The Allworx system automatically creates a folder in which users can store documents they intend to share.

10.1 Document Sharing through Your PC's Network Folder

1. Open the network folder on your PC's desktop.

Note: This may be called <u>Network Neighborhood</u> or <u>My Network Places</u> depending on your Windows environment.

2. Locate and open the folder labeled Allworx.

Note: Depending on your Windows environment, there may be additional folders to step through before reaching the Allworx folder (e.g., the Workgroup folder).

- 3. Locate and open the folder labeled <u>Users.</u>
- 4. You can now open any folder displayed to store and retrieve shared documents using the Windows features of your PC.

10.2 Document Sharing through a Browser

Shared documents can only be retrieved through a browser. Follow the steps in 9.1 above to place documents into shared folders.

- 1. Locate the browser application on your PC (Internet Explorer or Netscape).
- 2. <u>Double-click</u> on the browser icon to open a window.
- 3. In the <u>Address</u> field, type the following then press <u>Enter</u> or click <u>Go</u>:

http://corp.yourcompanydomainname/

Note: Contact your System Administrator if you do not know your company's domain name.




Figure 10-1 - Company and User Directory Display Screen

The screen in Figure 10-1 will appear showing company directory information and user listing information.

4. To locate shared *company* documents, click on the <u>Shared Files</u> link in the upper right corner of the browser window. Shared company documents may include human resources policies, vacation schedules or other important notices.

To locate shared *user* documents, click on the <u>Shared Files</u> icon next to the user's name. A window will appear displaying the available shared documents.

5. Identify the document you wish to open, then <u>double-click</u> on the document's icon. The application (for example, Microsoft Word) and the document will be launched automatically.

Note: If you have trouble launching a document, contact your System Administrator and review your browser's settings or desktop applications.

11 Internet and Intranet Access

11.1 Internet Access

Your Allworx system may already be connected to the Internet through your organization's Internet Service Provider. Check with your System Administrator for more information.

To access the Internet:

- 1. Locate the browser application on your PC (Internet Explorer or Netscape).
- 2. Double-click on the browser icon to open a window.
- 3. You are now ready to "surf" the Internet.

11.2 Intranet Access

An intranet is a private network reserved for use by people who are authorized to use it, and who have the appropriate passwords for access. An intranet may be used by one organization or several organizations that need to communicate. The Allworx system includes an intranet through which you and others in your organization can share information.

To access your organization's Allworx intranet:

- 1. Locate the browser application on your PC (Internet Explorer or Netscape).
- 2. <u>Double-click</u> on the browser icon to open a window.
- 3. Enter the address of the your organization's Allworx Intranet in the <u>Address</u> field. You may need to contact your System Administrator for this information.

http://corp.yourcompanydomainname/

4. You are now ready to search your organization's Intranet.



12 Remote Access to the Allworx Server

The Allworx system's virtual private network (VPN) feature provides secured remote access through the Allworx firewall to your organization's local area network. No special software is required on users' computers because Allworx uses the VPN features of Microsoft Windows 98, XP and 2000.

The Allworx VPN allows users access to the server regardless of location and without concern of compromising security. The System Administrator will enable VPN access for each user, and assign appropriate login user names and passwords.

This section provides information about:

- Configuring users' PCs for remote access
- Establishing remote connections

12.1 Setting Up Your Computer for Remote Access

12.1.1 Windows 2000

- 1. From your Windows screen open Network and Dialup Connections.
- 2. Double-click Make New Connection and click Next.
- 3. Select Connect to a private network through the Internet and click Next.
- 4. If you need to establish a dial up connection with your Internet Service Provider, click <u>Automatically dial this initial connection</u>, click a connection from the list, and click <u>Next</u>.
 - Or, if you do not want to automatically dial an initial connection, click <u>Do not dial the initial connection</u>, and click <u>Next</u>.
- 5. Type your Allworx host name or the Allworx static WAN IP address of the computer or network to which you are connecting and click Next.
- 6. If you want this connection to be made available to all users on your network, click <u>For</u> all users and click Next.
 - If you want to reserve the connection for your own use, click <u>Only for myself</u> and click Next.
- 7. Type a name for the connection and click Finish.
- 8. The Login window for this connection will appear. Click Properties.
- 9. Click on the Networking tab.



- 10. While Internet Protocol (TCP/IP) is highlighted in the window, click <u>Properties</u>.
- 11. Click Advanced...
- 12. Under the DNS server addresses, in order of use and click Add...
- 13. Type in the LAN IP address of the Allworx server and click Add.
- 14. Select Append these DNS suffixes (in order) and click Add...
- 15. Type in the Domain suffix of the Allworx server (such as "mycompany.com") and click Add.
- 16. Click OK (of the Advanced TCP/IP Settings window).
- 17. Click OK (of the Internet Protocol TCP/IP Properties window).
- 18. Click OK (of the VPN connection properties window).

Notes: To open Network and Dial-up Connections, click <u>Start</u>, point to <u>Settings</u>, and click <u>Network and Dial-up Connections</u>.

To make the connection available to all users, you must be logged on as System Administrator or as a member of the Administrator's group.

12.1.2 Windows XP Professional

- 1. Click <u>Start</u> and select <u>View Network Connections</u>, then <u>Create a New Network Connection</u>.
- 2. The New Connection Wizard will start. Click Next.
- 3. Select the Connect to the network at my workplace and click Next.
- 4. Select the appropriate device, such as the network interface card you will use to connect to the VPN and click Next.
- 5. Enter a unique Connection Name (such as *YourcompanyVPN*).
- 6. If you need to establish a connection with your ISP or some other network before tunneling to your destination computer or network, click <u>Automatically dial this initial</u> connection. Click a connection in the list and click Next.
 - Or, if you do not want to automatically dial an initial connection, click <u>Do not dial the</u> initial connection and click Next.
- 7. Type your Allworx host name or the Allworx static WAN IP address of the computer or network to which you are connecting. Click <u>Next</u>.



- 8. If you want this connection to be made available to all users on your network, click Anyone's use and click Next.
 - Or, if you want to reserve the connection for your own use, click My use only and click Next.
- 9. You may add a shortcut to the desktop with the newly created connection name if desired.
- 10. Click Finish.
- 11. The Login window for this connection will appear. Click <u>Properties</u>.
- 12. Click on the Networking tab.
- 13. While Internet Protocol (TCP/IP) is highlighted in the window, click Properties.
- 14. Click Advanced...
- 15. Click Add...under the DNS server addresses, in order of use
- 16. Type the <u>LAN IP address</u> of the Allworx server and click <u>Add</u>.
- 17. Select Append these DNS suffixes (in order) and click Add...
- 18. In the TCP/IP Domain Suffix dialog box, enter the Domain suffix for the Allworx server (such as "mycompany.com") and click Add.
- 19. Click OK to close the Advanced TCP/IP Settings window.
- 20. Click OK to close the Internet Protocol TCP/IP Properties window.
- 21. Click OK to close the VPN connection properties window.
- 22. Click Cancel to close the Login window.

12.1.3 Windows XP Home

- 1. Click <u>Start</u>. Select <u>Settings</u> and <u>Control Panels</u>.
- 2. Be sure your Control Panel is in the Category View mode. The right pane heading will read <u>Pick a Category</u>. If it does not, click <u>Switch to Category View</u> at the top of the left pane.
- 3. Click Network and Internet Connections.
- 4. Under Pick a task..., click <u>Create a connection to the network at your workplace</u>.
- 5. Select Virtual Private Network connection. Click Next.



- 6. If you need to establish a connection with your ISP or some other network before tunneling to your destination computer or network, click <u>Automatically dial this initial</u> connection. Click a connection in the list and click Next.
 - Or, if you do not want to automatically dial an initial connection, click <u>Do not dial the initial connection</u> and click <u>Next</u>.
- 7. Enter a name for the connection (for example, server2atmycompany). Click Next.
- 8. Type your Allworx host name or the Allworx static WAN IP address of the computer or network to which you are connecting. Click <u>Next</u>.
- 9. To place a shortcut for the VPN connection on the user's desktop, click <u>Add a shortcut to</u> this connection to my desktop. Click Finish to close the new connection wizard.
- 10. The Login window for this connection will appear. Click **Properties**.
- 11. Click on the Networking tab.
- 12. While <u>Internet Protocol (TCP/IP)</u> is highlighted in the window, click <u>Properties</u>.
- 13. Click Advanced...
- 14. Click Add...under the DNS server addresses, in order of use
- 15. Type the LAN IP address of the Allworx server and click Add.
- 16. Select Append these DNS suffixes (in order) and click Add...
- 17. In the TCP/IP Domain Suffix dialog box, enter the Domain suffix for the Allworx server (such as "mycompany.com") and click <u>Add.</u>
- 18. Click OK to close the Advanced TCP/IP Settings window.
- 19. Click <u>OK</u> to close the Internet Protocol TCP/IP Properties window.
- 20. Click OK to close the VPN connection properties window.
- 21. When the Login window appears, enter the user's <u>name</u> and <u>password</u>, or click <u>Cancel</u> to close the window.

12.2 Establishing Remote Connections

Double-click on the VPN connection you created in the previous section. The connection icon will either be on your desktop, or located under Network Connections.

When the Login window appears, enter your Allworx user name password provided by the System Administrator. Click <u>Dial</u> or <u>Connect</u>.

13 Working Offline from the Allworx Server

The Allworx Communication Center can be used while you are disconnected from the Allworx network. For example, if you are using a laptop PC while traveling, you can update your calendar, or add new contacts. Then, when you return to your office, the new information can be synchronized with the Allworx server.

To prepare your PC to work offline:

- 1. Click User Settings on the Task bar of the Allworx Communication Center.




Figure 13-1 – My Preferences Dialog Box for Office Synchronization

- 2. Click the My Preferences tab to define your preferences for Offline Synchronization. The window in Figure 13-1 will appear.

Click the selection that indicates your preference for synchronizing your PC with Allworx server information upon logging off from the Allworx Communication Center.

- <u>Always ask before synchronizing:</u> You will be asked if you wish to synchronize your PC with information stored on the server.
- Never ask, always synchronize: The systems will automatically synchronize information
- Never ask, never synchronize: You will not be asked and synchronization will not take place.

Click the Update button to save the information.

When you are preparing to leave the office:

- 1. Click Exit on the Allworx Communication Center Task bar.
- 2. Click Yes to exit the application.




Figure 13-2 – Database Synchronization Confirmation Box

The window in Figure 13-2 will appear if you previously selected <u>Always ask before</u> synchronizing. Click Yes to begin synchronizing. Click No to just exit the application.

If you selected Never ask, always synchronize, synchronizing will begin automatically.




Figure 13-3 – Synchronization Progress Window

The Synchronization Progress dialog box is shown in Figure 13-3. All database information will be synchronized. The box will close automatically when the process is finished.
